

PERSONNEL ORDER 2012 – 50

RE: DISCIPLINARY ACTION

POLICE TELECOMMUNICATOR DOROTHY J. BALLARD, (016732), Technical Communications Division, charged with violation of Department Rules and Procedures as follows:

Core Value 1.00 - Competence, referencing Guiding Principle 1.02: Failure to cooperate with a citizen to ensure public safety.

Core Value 1.00 - Competence, referencing Guiding Principle 1.05, referencing Milwaukee Police Department Technical Communications Division Assignment Classification Manual relating to Call For Police - Section 1603: Failure to enter an assignment as a "Call for Police" after police service had been requested.

The charges having been substantiated, she is found guilty as charged and the penalty adjudged appropriate by the Chief of Police is as follows:

Failure to cooperate with a citizen to ensure public safety.	Ten (10) day suspension without pay.
Failure to enter an assignment as a "Call for Police" after police service had been requested.	Five (5) day suspension without pay.

It is hereby ordered that POLICE TELECOMMUNICATOR DOROTHY J. BALLARD be suspended without pay for a total of fifteen (15) working days. If not appealed, said suspension shall be served during the following periods: May 30, 2012 through June 5, 2012; and June 17, 2012 through June 30, 2012.
