

Rule 4, Section 380.00; Core Value 1.00 – Competence, referencing Guiding Principle 1.03: Failure to render service promptly and efficiently. (Count One)

Rule 4, Section 380.00; Core Value 1.00 – Competence, referencing Guiding Principle 1.03: Failure to render service promptly and efficiently. (Count Two)
