

POLICE OFFICER ERIC J. ROM, (015504), Third District, charged with violation of Department Core Values as follows:


Core Value 3.00 - Integrity, referencing Guiding Principle 3.05: Failure to obey the ordinances in effect in the City of Milwaukee.


