A Regular Meeting of the Board of Fire and Police Commissioners was held on the above date, commencing at 5:33 p.m.

The Director presented for adoption minutes of the Regular Meeting and the Special Town Hall Meeting of September 18, 2014, and the Special Meeting of May 15, 2014. Commissioner O'Hear moved approval of the minutes, seconded by Commissioner Hein. The motion carried unanimously.

1. UNFINISHED BUSINESS:

a) The Director presented the Decision and Order from the Milwaukee Circuit Court regarding the appeal of former Police Officer Richard Schoen from discipline imposed by Milwaukee Police Department Chief Flynn on May 1, 2012. He stated the Circuit Court upheld the Fire and Police Commission's decision to discharge Richard Schoen from the Milwaukee Police Department.

2. EXAMINATIONS:

a) The Director presented for approval the Office Coordinator (MFD) Job Announcement Bulletin. He stated the position is a transfer/promotional opportunity for current employees. Commissioner O'Hear moved approval of the job announcement bulletin, seconded by Commissioner DeVougas. The motion carried unanimously.

3. FIRE DEPARTMENT:
