

POLICE OFFICER JENNIFER M. MISHICH, (018126), Technical Communications Division, charged with violation of department Core Values as follows:


Core Value 1.00 – Competence, referencing Guiding Principle 1.04: Failure to prepare reports in a prompt and thorough manner.
